AMERICAN EDUCATION SERVICES JOINS
FINANCIAL INSTITUTION SHARED ASSESSMENTS PROGRAM

JUNE 15, 2006, Washington, DC – BITS and American Education Services (AES) announced today that AES has joined the Financial Institution Shared Assessments Program.

The Financial Institution Shared Assessments Program was introduced in February 2006. Since then, more than 20 major US financial institutions and service providers have joined the Program, which allows reports on service provider security testing to be shared among participating financial institutions.

The Financial Institution Shared Assessments Program has been praised for raising the bar on financial services security while introducing cost savings for financial institutions and service providers. The Shared Assessments Program was created by BITS, a nonprofit, CEO-driven consortium of 100 of the largest financial institutions in the US. Strategic consulting company The Santa Fe Group manages the Shared Assessments Program for BITS.

AES Vice President of Internal and IT Audit, Dawn Bard, will represent AES on the Financial Institution Shared Assessments Program working group. Ms. Bard is a CPA and a Certified Information Systems Auditor. She has been with AES for twelve years and is responsible for conducting all company internal audits. Ms. Bard works closely with the AES Board of Directors'

Audit Review Committee and executive management to manage risk, and evaluate and improve related controls.

The Financial Institution Shared Assessment Program is based on American Institute of Certified Public Accountants standards. “Instead of fifty different institutions independently evaluating one service provider,” said Catherine A. Allen, CEO of BITS, “The Shared Assessments Program allows companies to share service provider assessments. It’s tremendously more efficient.” Ms. Allen is also Chairman and CEO of The Santa Fe Group.
